

OSAA Season 1 Reopening Safety Plan

Publication Date: Nov. 5, 2020

PURPOSE: To prevent and or reduce the possible spread of COVID-19 while safely operating during OSAA Season 1, November 9, 2020 - December 27, 2020, as a bridge and skill building time for our HSD Student Athletes and their families. These guidelines have been developed in alignment with the October 15, 2020 state reopening guidance for school sports from the Oregon Health Authority ([Statewide Reopening Guidance: K-12 School Sports Limited Return to Play](#)).

SCOPE : These procedures apply to all HSD OSAA Season 1 Athletic Activities for staff, students, and family members entering the HSD High School facilities.

RESPONSIBILITY: All persons entering HSD sites under the umbrella of HSD Athletics and Activities are expected to follow guidelines set forth in this document at all times.

GUIDELINES & INSTRUCTIONS:

1. Ensuring Continued Public Health

- a. HSD District Office Administrators and/or site based Athletic Directors are designated as the “health and safety officers,” responsible for establishing, implementing, and enforcing social distancing requirements consistent with this plan and guidance from OHA , HSD, and OSAA.
- b. Vulnerable populations will be asked to continue to stay at home.

2. Planning, Procedures, and Logistics

- a. Planning & Preparation:
 - i. Coaches and Participants: Participating staff and families will be advised not to report/send their students to school if the staff member or student exhibits any of the symptoms or has experienced potential exposure to COVID-19 per the current exclusion guidance: <http://bit.ly/exclusionchart>. This information is also available via each school’s Family ID portal and Remind.
 - ii. Physical Space: Outdoor facilities used for the HSD reopening will be physically distanced from one another and will be mapped appropriately to support physical distancing between students and staff.
 - iii. Training: All HSD Athletic and Activity staff responsible for training and instruction during the HSD Reopening Plan will complete all mandatory training prior to working with students.

b. Screening for Symptoms:

- i. Student and Staff Screening: For each Athletic and Activity Session, families will be asked to answer a set of health screening questions about their child. Students and staff will go through a visual screening process as outlined by HSD.
- ii. Display of Symptoms: If a student begins to display symptoms and/or fever at the time of screening or during the athletic activity, they will be isolated in a designated space and the family will be immediately called to pick them up.
- iii. Confirmed case: If there is a confirmed case of COVID-19 in the program, staff will follow HSD COVID-19 Positive Case Protocol Flowchart.

c. Physical Distancing:

- i. Athletic Facility Assignment & Set-Up: Students will be assigned to cohort groups of up to 25 students. Each cohort will be assigned to one athletic facility space and will be supported by an athletic coach. All HSD Reopening program activities will take place within cohort groupings. Athletic facilities will be set-up and possibly marked to allow six-feet between students during athletic activities.
- ii. Athletic Workouts/Practice: Cohort groups will be assigned specific “zones” and times for allowable athletic activities. Each cohort will have its own athletic equipment (e.g. balls, jump ropes)--this equipment will be sanitized at the end of each athletic period. Athletic Coaching Staff will support students with skill building and conditioning activity plans in accordance with social distancing. Based on OSAA guidelines.
- iii. Arrival & Dismissal: Arrival and dismissal times will be staggered at each site to avoid crowding. Facility schedules will be up to two hours a day and max six hours per week in length with at least a 15 minute buffer for cleaning and exit of participants. An arrival table/location/landmark will be set-up for each site based on site layout. Parents/guardians and students will wait in a physically-distanced area for check-in. Parents will not be allowed to enter the athletic facility. The arrival and dismissal procedure will include:
 1. Health screening questions upon arrival
 2. Temperature check upon arrival (during Phase 1 only)

3. Use of hand sanitizer or washing hands with soap and water
4. Staff completion of Daily Log* (indicating when each student arrives, who dropped them off, parent/guardian contact information, and staff they will have contact with during the day)
5. Upon arrival, students will go to their athletic area.
6. At the end of the day, parents/guardians will wait in a physically-distanced area as students exit the facility. They will not be allowed to enter the athletic facilities.

**Daily Logs will be kept for at least four-weeks following the conclusion of the program in case contact tracing becomes necessary.*

- iv. Item Sharing: Students will not be allowed to share personal equipment, water bottles, food, clothing, or bags.
 - v. Visitors & Volunteers : No non-essential visitors or volunteers (including parents/guardians) will be allowed to enter the athletic area.
- d. Healthy Hygiene Practices:
- i. Face Coverings: It is required that HSD Athletic and Activity staff and students wear a face covering* during program hours in accordance with current guidance (*no gaiters or bandanas; face shields allowable only in combination with a mask or face covering). They should be reminded not to touch their face coverings. Staff should provide their own face covering. If a staff member or student is unable to provide one for themselves or they forget their face covering, the program will provide one.
 - ii. Hand-Washing: HSD Athletic and Activity staff will promote daily hygiene protocols and provide handwashing and/or hand sanitizing facilities, tissues and garbage receptacles that are easily accessible to both students and staff.
 - iii. Respiratory Etiquette : HSD Athletic and Activity staff will teach, model, and reinforce “respiratory etiquette,” supporting students to cover coughs and sneezes.
- e. Cleaning, Disinfection, & Ventilation:
- i. Cleaning: Staff will clean, sanitize, and disinfect frequently touched surfaces (e.g. athletic equipment, door handles, sink handles, etc)

between uses multiple times per session.

- ii. Water: students must bring their own water bottles. HSD will provide bottled water for emergency purposes.
 - iii. Safety: Staff will be trained by HSD Facility staff in safe and correct application of disinfectants and will keep these products away from students.
- f. Other Programming Same Site:
- i. Shared Facility: Staff will coordinate with other programs to ensure proper social distancing and cleaning protocols. There will be no sharing of physical spaces during any aspect of the HSD Season 1 Reopening with other programs at the shared site. This includes entry and exit points, or athletic facilities.
